#### I—DISTINGUISHED SERVICE CROSS.

By direction of the President, under the provisions of an Act of Congress approved 9 July 1918 and amended 25 July 1963, the Distinguished Service Cross for extraordinary heroism in action is awarded to:

Captain Walter T. Holmes, 68th Bombardment Squadron, 44th Bombardment Group (H), European Theater of Operations on 1 August 1943, while serving as the squadron's Operations Officer in aerial combat operations over the Ploesti Oil Refineries of Rumania. Captain Holmes piloted a lead aircraft in a formation of B–24 type aircraft that attacked a highly important oil refinery at extremely low altitude. Because of the nature of the target, it was imperative the lead pilot follow an exact course to and over the target. Some fifteen miles before reaching the objective, Captain Holmes' aircraft was subjected to heavy point blank anti-aircraft and machine-gun fire. Knowing that evasive action would disrupt the close flying formation, Captain Holmes, thinking only of the complete destruction of his separate target ahead, and with complete disregard for personal risk of life, kept fast to the course, leading his formation through fire and smoke straight over the target. His courageous determination and exceptional piloting skill resulted in the successful and full destruction of his target. Captain Holmes' actions are in keeping with the finest traditions of military service and reflect great credit upon him, the 44th Bombardment Group, and the United States Army.

#### II-LEGION OF MERIT.

By direction of the President, under the provisions of an Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (**Degree of Officer**) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

**Major General Georgios Bardamaskos,** Hellenic Armed Forces, July 2005 to July 2006. This order supersedes United States Army Human Resources Command, Permanent Order 361–13, dated 27 December 2007.
